Priest/Minister that was conducting the communion, refused to give her the communion bread. [REDACTED] advised Father Fidel informed her, she did not do the prior steps necessary to be given the communion bread.

[REDACTED] further advise, she informed the Priest she did in fact do the steps necessary and is now accepted by God, Thus, granting her the ability to participate in communion. [REDACTED] then advised Father Fidel became upset and tried to ram the "cookie" in her mouth. In response, [REDACTED] advised she attempted to grab another communion bread which Father Fidel was holding, however, Father Fidel grabbed her and bit her arm. [REDACTED] refused medical attention and I took photograph evidence of the bit mark. [REDACTED] indicated in the written statement provided that she wanted to Prosecute

I then interviewed Santibanez which collaborated [REDACTED] story. In addition, Santibanez advised Father Fidel singled [REDACTED] out because of her sexuality and attire.

I continued my investigation by contacting Father Fidel at the church. Father Fidel informed me [REDACTED] attended an earlier Mass that day, to which he informed her of the proper steps necessary to receive communion. Father Fidel further advised [REDACTED] decided to come to another Mass to receive communion, however, he denied her according to the rules of the Catholic faith. Father Fidel further advised [REDACTED] got upset and attacked him. Father Fidel informed me that when [REDACTED] grabbed the communion tray of bread out of his hands, it is considered sacrilege, as the Catholic faith considered the communion bread the body of Christ, and he was trying to protect it. Father Fidel advised that [REDACTED] pushed him and would not let go of the communion tray and the only way he thought to extract her from it was to bite her arm.


I then interviewed other members of the service who witnessed the incident which collaborated Father Fidel statement and provided video evidence of the incident.

The parties involved provided a written statement, was given the victim rights pamphlet, and the Marcy's law form.

At the conclusion of my investigation, I determined in an attempt to defend the Communion bread Father Fidel held as sacred, he bit the arm of [REDACTED] I completed an Affidavit of Prosecution Summary to be forwarded to the State Attorney's Office for review.

My entire encounter was captured on my BWC.
